Active board members are required to update their personal conflict of interest questionnaire at an annual board meeting.

The Board Chair and President/CEO review the completed questionnaires, and the Chair routinely reminds board members of the need or suggestion to abstain from related votes, if warranted.

Pt VI, Line 15b: The President/CEO of the organization prepares an annual review of each of the organization's employees and shares the review content with the Compensation Committee. The Compensation Committee is comprised of a cross-section of board members who are also familiar with the operations and staff of the organization. The committee operates independently of the Board under budget constraints that may be imposed by the Board's Finance Committee. As part of the review of each individual, the President/CEO submits salary history, inflation statistics, internal budgetary guidance, and compensation comparability data to the committee members.

President/CEO makes recommendations for consideration in the area of gross pay and employer-funded retirement and other employer-funded group benefits, including but not limited to health benefits.
